

Promotion Terms and Conditions: "11th Product for One Cent"

§1 General Provisions

- 1) The organizer of the "11th Product for One Cent" promotion, hereinafter referred to as the "Promotion", is Art.Mas Import-Export Jacek Bińczyk Wojciech Bińczyk Sp. k., with its registered office in Radom, ul. Żółkiewskiego 64, 26-600 Radom, registered into the Register of Entrepreneurs of the District Court Lublin-East in Świdnik, 6th Commercial Division of the National Court Register under KRS number 0000965465, NIP 948-21-79-432, hereinafter referred to as the "Organizer".
- 2) The Promotion is intended for the entities specified in §3 of these Terms and Conditions.
- 3) The Promotion involves adding one additional product to an order of 10 products from the same assortment from the list of products participating in the Promotion.

§ 2 Duration

- 1) The Promotion runs from June 9, 2025 until it is either cancelled or the promotional stock is sold out.
- 2) The Organizer reserves the right to extend or shorten the Promotion period in the event that the promotional products sell out before the date (if mentioned) in item 1 above, or to selectively shorten the duration for specific products.

§ 3 Participants

- 1) The Promotion is open to sole proprietors, civil law partnerships, registered partnerships, and professional partnerships (hereinafter referred to as "Participants") who purchase goods from the Organizer's assortment solely for resale purposes.
- 2) Individuals who are not conducting business activity and any other entities not involved in the resale of the Organizer's products are excluded from the Promotion.

§ 4 Promotion Rule

- 1) To qualify for the Promotion, a Participant must place an order via the Organizer's e-shop at www.artmas.pl, by phone at +48 365 41 19, or by email (customer service email addresses available at artmas.pl under the "Contact" tab), for the promotional products (shorts):
 - a) Professional 4 Dynamic,
 - b) Classic Stretch Slim (shorts): Grey, Navy Blue, White-G;
 - c) EuroClassic,
 - d) Professional Grey,
 - e) Flash Orange and Yellow,
 - f) Procotton, Classic 100 Slim,
 - g) Classic 100 Stretch Slim.
- 2) After meeting the condition described in §4.1, the Participant automatically receives an additional, 11th product added to the order for the price of 0,01 PLN, 0,01 EUR or 0,01 USD. The 11th product will be added in the size that is currently most in stock, unless the Participant specifies otherwise at the time of ordering.

- 3) The Promotion applies to orders placed via www.artmas.pl, by phone, or by email.

§ 5 Complaints

- 1) All complaints regarding the Promotion may be submitted by email to bok@artmas.pl or by phone at +48 48 365 41 19.
- 2) The complaint should include detailed information about the Participant: company name, tax identification number (~~NIP~~), contact number, and the basis for the complaint.
- 3) Complaints will be processed within 14 days from the date of receipt.
- 4) The complainant will be informed of the outcome by email or through the contact information provided during the phone inquiry.

§ 6 Final Provisions

- 1) The Terms and Conditions are available at www.artmas.pl.
- 2) Participation in the Promotion implies acceptance of these Terms and Conditions.
- 3) These Terms and Conditions are the only binding document outlining the rules of the Promotion. Promotional materials are for informational and promotional purposes only.
- 4) Any disputes arising from or related to the Promotion shall be resolved by the court having jurisdiction according to the provisions of the Polish Code of Civil Procedure.
- 5) The Organizer reserves the right to amend the Terms and Conditions, provided that such amendments do not worsen the conditions of participation in the Promotion. Changes will apply to Participants placing orders after the amendments take effect.
- 6) Art.Mas Sp. k., with its registered office in Radom, 26-600, ul. Żółkiewskiego, informs that it is the data controller of the personal data processed to execute the Promotion under these Terms and Conditions. Data is provided voluntarily, and the individual or entity to whom the data relates has the right to access and correct it. Data will not be shared with entities not directly involved in order fulfillment.
- 7) For the purpose of running the Promotion or processing complaints, the Organizer processes the following data: company name, first and last name, email address, mobile or landline number, mailing address, REGON, and tax identification number of the Promotion Participant.
