

Promotion Terms and Conditions: "Jacket at Half Price"

§1 General Provisions

- 1) The organizer of the "Jacket at Half Price" promotion, hereinafter referred to as the "Promotion", is Art.Mas Import-Export Jacek Bińczyk Wojciech Bińczyk Sp. k., with its registered office in Radom, ul. Żółkiewskiego 64, 26-600 Radom, registered into the Register of Entrepreneurs of the District Court Lublin-East in Świdnik, 6th Commercial Division of the National Court Register under KRS number 0000965465, NIP 948-21-79-432, hereinafter referred to as the "Organizer".
- 2) The Promotion is intended for the entities specified in §3 of these Terms and Conditions.
- 3) The subject of the Promotion is the purchase of a minimum of one pair of Classic Camou trousers, entitling the Participant to purchase a Classic Camou jacket at a 50% discount.

§2 Duration

- 1) The Promotion is valid from 26.06.2025 for a period of two weeks or until the promotional stock is sold out.
- 2) The Organizer reserves the right to shorten the Promotion for individual products or end it entirely upon achieving sales targets. The Promotion may also be extended.

§3 Participants

- 1) The Promotion is open to sole proprietors, civil law partnerships, registered partnerships, and professional partnerships (hereinafter referred to as "Participants") who purchase goods from the Organizer's assortment solely for resale purposes.
- 2) Individuals who are not conducting business activity and any other entities not involved in the resale of the Organizer's products are excluded from the Promotion.

§4 Promotion Rules

- 1) To qualify for the Promotion, a Participant must place an order via the Organizer's e-shop at www.artmas.pl, by phone at +48 365 41 19, or by email (customer service email addresses are available at artmas.pl under the "Contact" tab) for products included in the promotion: for each pair of Classic Camou trousers purchased, the Participant is entitled to buy a Classic Camou jacket at half the price applicable to their discount tier.
- 2) After meeting the condition described in §4.1, the Participant is entitled to a discount on the Classic Camou jacket.
- 3) The Promotion applies to orders placed via www.artmas.pl, by phone, or by email.
- 4) The Promotion includes the following products:
 - a. **Classic Camou Trousers**
 - b. **Classic Camou Jacket**

§5 Complaints

- 1) All complaints regarding the Promotion may be submitted by email to bok@artmas.pl or by phone at +48 48 365 41 19.

- 2) The complaint should include detailed information about the Participant: company name, contact number, and the basis for the complaint.
- 3) Complaints will be processed within 14 days from the date of receipt.
- 4) The complainant will be informed of the outcome by email or through the contact information provided during the phone inquiry.

§6 Final Provisions

- 1) The Terms and Conditions are available at www.artmas.pl.
- 2) Participation in the Promotion implies acceptance of these Terms and Conditions.
- 3) These Terms and Conditions are the only binding document defining the rules of the Promotion. Promotional materials are for informational and promotional purposes only.
- 4) Any disputes arising from or related to the Promotion shall be resolved by the court having jurisdiction according to the provisions of the Polish Code of Civil Procedure.
- 5) The Organizer reserves the right to amend the Terms and Conditions, provided such amendments do not worsen the conditions of participation in the Promotion. Changes will apply to Participants placing orders after the amendments take effect.
- 6) Art.Mas Sp. k., with its registered office in Radom, 26-600, ul. Żółkiewskiego, informs that it is the controller of the personal data processed to execute the Promotion under these Terms and Conditions. Data is provided voluntarily, and the individual or entity to whom the data relates has the right to access and correct it. Data will not be shared with entities not directly involved in order fulfillment.
- 7) For the purpose of running the Promotion or processing complaints, the Organizer processes the following data: company name, first and last name, email address, mobile or landline number, mailing address and tax identification numbers of the Promotion Participant.
